TERMS AND CONDITIONS

Tender for Transport of Animal Feeds, Medicines, Livestock and other inputs

Sealed tenders are invited from National Registered Transporters for Transportation of Animal Feeds, Livestock Medicines, Livestock and other inputs to various Dzongkhags and Central Units / Projects. Documents required: Copy of Valid Transport License, Tax Clearance Certificate and Citizenship Identity Card copy of the owner.

The tender is to be submitted in the enclosed format and are subject to the terms and conditions specified below:

1. The bidder shall prepare ONE Original of the documents comprising the bid and clearly mark it "ORIGINAL". In addition, the bidder shall submit one copy of the bid and clearly mark it "COPY". In the event of any discrepancy between the original and the copy, the original shall prevail.
2. Bids shall be delivered by hand, courier or registered post. The bidder shall seal the original of bid and the copy in separate inner envelope contained within one outer envelope. All envelopes shall be sealed with adhesive or other sealant to prevent reopening.
 - 2.1. The inner envelope shall be signed across their seals by the person authorized to sign the bid on behalf of the bidder.
 - 2.2. The inner envelope shall be marked "Original" and "Copy".
 - 2.3. The outer envelope shall be marked "Confidential" and provide a warning not to open before the specified time and date for bid opening.
 - 2.4. The outer envelope shall be addressed to the purchaser at the address given and marked as "TENDER FOR TRANSPORTATION 2018-2019"
- 2.5. The purchaser shall not consider any bid that arrives after the deadline for submission of bids. Any bid received by the purchaser after the deadline for the submission of bids shall be declared late, rejected and returned unopened to the bidder.
